











Why Export?

- 96% of the Global Market is Outside the U.S.
- Statistics:
 - Kansas Exports, 2023: \$14.1 Billion
 - Kansas Exporters, 2022: about 3,500
- Key Reasons to Export:
 - Reaching New Customers
 - Technology Exchange
 - "Low Seasons" in the Domestic Market Could be "High Seasons" in a Foreign Market

- Combining our export grants into one will streamline the application and approval process
- Each approved company can utilize up to \$10,000 in reimbursements on eligible expenses, including:
 - Trade shows expenses
 - Overseas travel
 - Internationally-focused marketing material
 - Translation
 - Overseas consultant fees

STEP (State Trade Expansion Program)

 The State Trade Expansion Program (STEP), funded in part by the U.S. Small Business Administration, helps Kansas non-exporters get started and existing exporters expand into additional foreign markets.

Assistance



Certificate of Free Sale

- The Certificate of Free Sale certifies that the specified exported goods are normally and freely sold in the exporting country's open market and are approved for export.
- The Kansas Department of Commerce issues this certificate upon request for all non-consumable goods.



International Credit Report

- About to close a deal with a new international customer?
- Want to add a new agent/distributor to your marketing efforts?
- Commerce is partnered with Kreller Group to provide Kansas exporters with quality credit reporting at reduced rates.
- All Kansas-based companies are eligible to receive reduced-rate international credit reports.



Export Kansas - Coming Soon!

- Designed to help new or early-to-export companies enter a new global market
- Identifies the top markets for a company's product or service
- Provides market research on five countries
- Introduces the company to distributors or sales channel partner in one country for potential market entry
